Sumner County shall accept bids for equipment that is equal to or better than the Nivisys PVS-7B/D Commercial Exportable Night Vision Goggle. The base bid must include cost for the goggle and a PASGT helmet attachment. The vendor must include a copy of the product literature with the bid document.

The vendor must also include pricing for any kits, options, accessories and features that would constitute additional cost above the base bid. The vendor must list this pricing on a separate sheet of paper.
