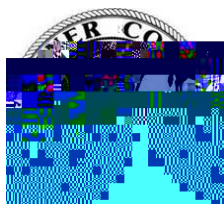

Courthouse Boiler (located on 4th floor in boiler room) is in need of replacement at Sumner County Courthouse. Sumner County is requesting proposals for the following:

Provide labor and materials to perform the following:

- ™ Disassemble and dispose of existing boiler, hydronic pump and associated piping
- ™ Install new 500,000 btu input boiler and hydronic pump
- ™ Install new hydronic piping and insulation from points of disconnect to new boiler and pump
- ™ Install new venting from boiler to existing vent
- ™ Install new gas piping and electrical conduit and conductors from points of disconnect to new boiler
- ™ Provide startup for new boiler and pump and verify proper operation
- ™ Install reducing valve (water)
- ™ Install new disconnect starter box for motor pump (heat)
- ™ Install two (2) new disconnect starter box for motor pump (air conditioning)
- ™ Install new flow switch
- ™ Provide for any changes for code required by Tennessee boiler inspector.
- ™ Installation of controls for 3 way valve as separate item. County reserves right to remove this item from project.

Interested bidder is required to complete a site visit with County Maintenance staff. Please contact County ([H F X W L Y H ¶ V - 452-3654] to set up time to review scope of work. Site visit is mandatory to review scope. It is the responsibility of each respondent to this request, to verify the scope of work as basis of the proposal. All respondents to this request shall be responsible for any errors or omissions. Each respondent is required to conduct a site visit with County Maintenance to validate their proposal

Work completed shall meet and conform with all applicable codes and regulations

Respondent shall provide a list of job references for similar projects completed in past three years, see form in proposal packet.

Respondent shall provide length of time necessary to complete the project and description of the length and terms/conditions of the warranty.
